

Mosiac Mural at 900 W Rundberg Ln.








# **Neighborhood Partnering Program Application Summary**

Project Name: Quail Creek Painted Bridges and Sidewalk Project

**Applicant:** North Austin Civic Association (NACA)

Project location: Fourteen bridges and retaining walls in the NACA boundaries.



# **Project Scope & Description**

- Fourteen bridges and two retaining walls have been selected for painting with designs with one bridge
  installing a mosaic mural. The project also includes the construction of a missing sidewalk segment along
  Fairfield Drive from Jamestown Drive to Delaware Court. Alternative sidewalk segments have been
  identified along Jamestown Drive, if Fairfield Drive segment is cost prohibitive.
- Project concept has been reviewed and approved by staff at the Public Works and Watershed Protection Departments. Artistic elements will be take to the Arts Commission for approval.

\*Individually each project site meets the 60 percent approval for Impacted Stakeholders

- NACA will design, install and maintain painted murals and one mosaic mural on fourteen bridges and two retaining walls. NACA will fundraise to provide in-kind donations for art materials totaling \$3,877.
- The City will construct a segment of sidewalk within the NACA neighborhood boundary and repair the retaining wall not to exceed the budgeted figure of \$66,018 for sidewalk improvements, \$10,000 for a retaining wall, plus contingency, totaling \$98,823.
- Letters of Support were received for this project from: Valero Corner Store (9433 Parkfield), El Palacio Event Center, Rundberg Rising, North Austin Civic Association (NACA) Neighborhood Association, UT's Social of Social Work, and the Principles of Austin ISD for Woolridge Elementary School, McCallum High School, Sidney Lanier High School.

# **Quality of Life Enhancements**

- Designs on the bridges of flowers and wildlife will enhance the experience for the many walkers in the neighborhood as well as potentially slow down traffic.
- Neighborhood beautification is in line with known evidence-based practice for crime reduction and supportive of Restore Rundberg Revitalization, Austin Police Department and Code Enforcement.
- The neighborhood has indicated that the particular part of Fairfield Drive has a blind curve and a sidewalk will provide better pedestrian conditions.

# **Incorporation of City Initiatives**

- The Fairfield and Jamestown Drive sidewalk segments are high priority segments in the Sidewalk Master Plan.
- Sidewalk alternative 3 is Item 24h in the North Austin Civic Association Neighborhood Plan is to "Construct a sidewalk on the 8300 block of Jamestown Drive."
- North Austin Civic Association Neighborhood Plan Goal 3 is to "Create a more pedestrian and cyclist friendly neighborhood by adding sidewalks and improving access to major centers of neighborhood activity."
- Encourage grassroots, neighborhood based organizations and activities that promote art, imagination, and creativity to enhance the role the arts play in community life (Imagine Austin -C P14).
