## **Project Scope & Description**

- Project is to replace the swaths of asphalt that occur because the intersections meet at acute angles with green spaces at 4 locations: 1) W. 39<sup>th</sup> St. and Ridgelea Dr., 2) W. 39<sup>th</sup> St., Idlewild Rd., and Bull Creek Rd. 3) Jefferson St. and Pete's Path; 4) Jefferson Street and Ridgelea Dr. Also included in the project are pinchers on Jefferson St. just north of Emilie Court and construction of 150 linear feet of curb on the 3800 block of Pete's Path. Where appropriate, green spaces will also serve as rain gardens.
- Project has been vetted through appropriate staff at Public Works, Austin Transportation and Watershed Protection Departments.


